We wish to recognize individuals, teams or companies that have shown exemplary work, initiative, and leadership.



## Award Categories

### Safety Action Award

- Awarded to a person or project team (does not have to be a PSM or HSE professional).
- Relates to PSM or HSE.
- All members are eligible.
- Nominate actions that have resulted in improved safety result or process.
- Describe how they have impacted the likelihood or potential of preventing an accident or incident (health or environmental) through technology implementation, process change, communication/education, or other.

### Step Change in Safety Award

- Awarded to a company.
- Encompasses PSM or HSE related topics.
- All member companies are eligible.
- Nominate actions that have resulted in significant process change or organizational culture change, focus on innovation or broader step changes.
- Describe how they have demonstrated a shift whether in participation or signup numbers, increased reporting of near misses, or other metrics.

### Environmental Leadership Award

- Awarded to a person, project team or company.
- All members are eligible.
- Nominate actions that have resulted in a positive measurable environmental impact that went above and beyond regulatory requirements.
- Describe how they have applied an innovative technology or process to make environmental improvements.

## Nominations:

- You may apply on your own behalf or nominate another company, team or individual.
- Nominees must be a UPA member company or an employee thereof.
- Nominee efforts must have occurred within the last 3 years.
- All entries will be judged by a panel

All awards will be announced at the UPA Annual Meeting in March 2024, as well as promoted on social media and highlighted in the UPA UDate Newsletter. Winners will also be highlighted in a press release from UPA.
